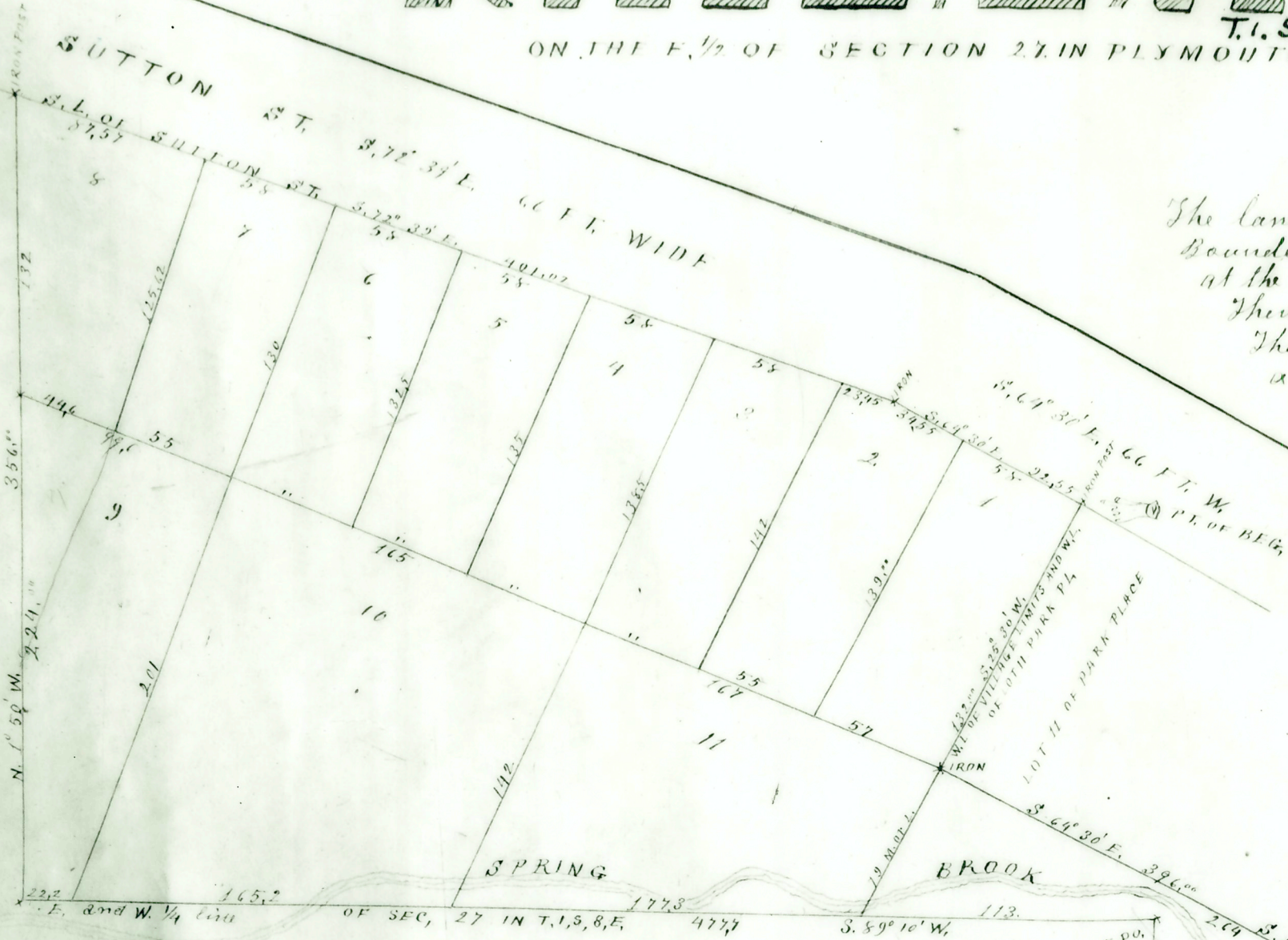

SUBDIVISION A

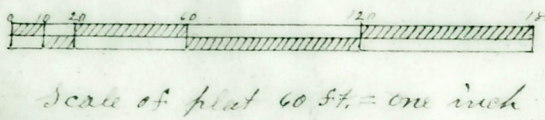


Description of the land platted
 The land embraced in Kate E. Allen's Subdivision A, is bounded and described as follows, beginning at an iron post at the N.W. corner of lot 11 of Park Place Subdivision. Thence along the W. line of said lot, S. 25° 30' W. 132 feet to an iron post. Thence along the S. line of Park Place, S. 68° 30' E. 394 feet to a fence post. Thence S. 25° W. 189 feet to a fence post. Thence S. 25° W. 190.7 feet to a fence post. Thence S. 25° W. 240 feet to a fence post. Thence S. 25° W. 497.7 feet to an oak post. Thence S. 25° W. 356 feet to an iron post on the S. line of Sutton St. Thence along said line S. 72° 30' E. 401.2 feet to an iron post. Thence S. 68° 30' E. 394 feet to the point of beginning.

Know All Men by these Presents, that I Kate E. Allen as proprietor, have caused the land embraced in the annexed plat, to be surveyed, laid out and platted to be known as Kate E.
