DESCRIPTION

The land embraced in the annexed plot is described as follows:-
 Beginning at the S.E. Corner of Sect. 34, T. 15. R. 8. E. Plymouth Twp. Wayne Co. Mich.: thence North 2646.00 feet along the East line of said Sect. 34 and the center line of Canton Road, so called, to the East $\frac{1}{4}$ Post of said Sect. 34: thence N. 89° 33' W. 735.80 feet, along the East and West $\frac{1}{4}$ line of said Sect. 34 and the center line of Golden Road, so called, to an iron stake: thence South 2646.45 feet to an iron stake in the South line of Sect. 34 and center line of Townline Road between Plymouth and Canton Twp.: thence S. 89° 35' E. 735.80 feet along said South Section line and Townline Road Center to the Point of Beginning.

I hereby certify that the plat hereon delineated is a correct one and that permanent monuments, consisting of Iron Gaspipes - 18 inches long have been planted at points marked thus: o as thereon shown at all angles in the boundaries of the land platted, and at all inter-sections of streets or streets and alleys.



