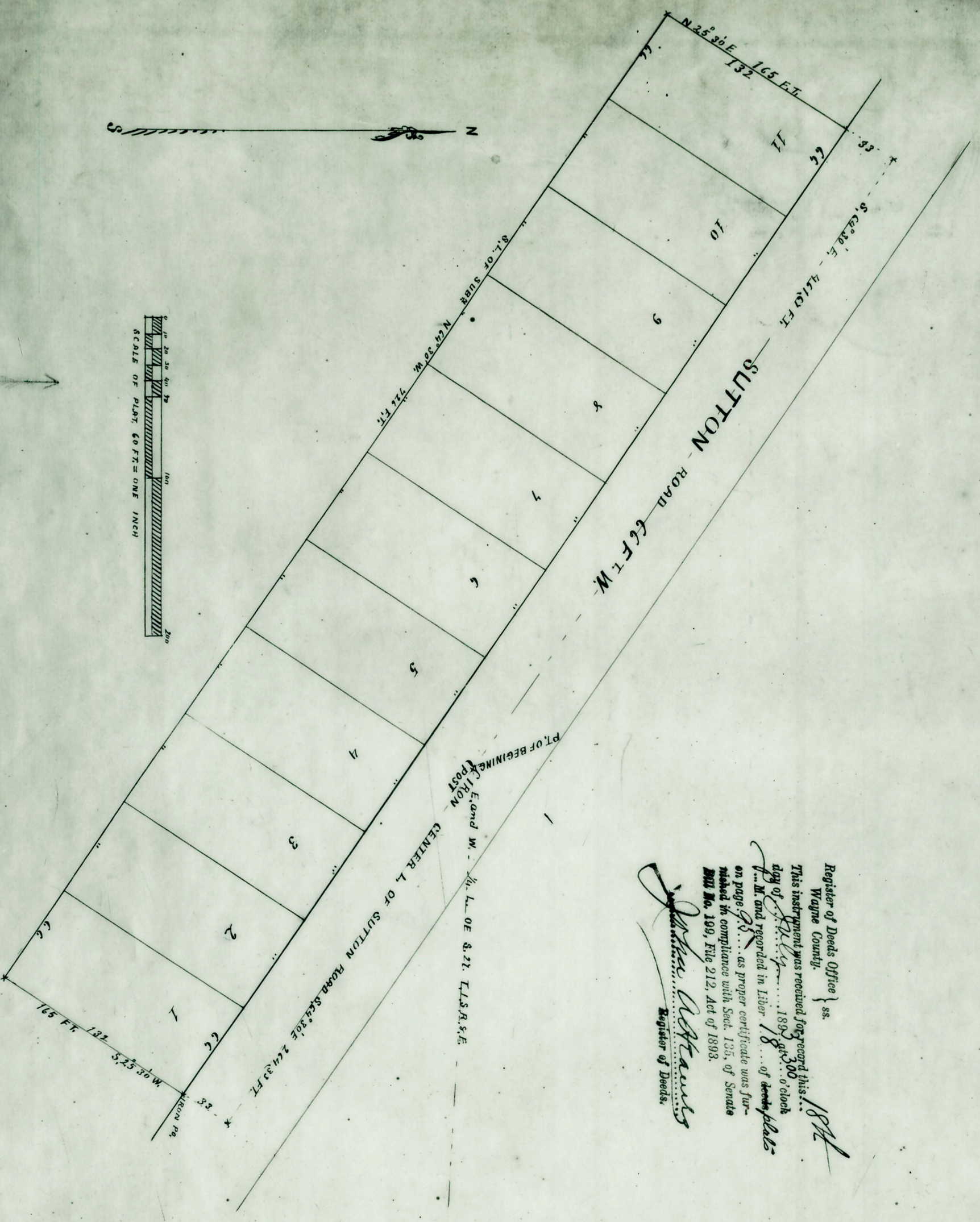

 thence N 75° 30' E 115 ft to the center of the Sutton Road thence along the center of said Sutton
 Road S 19° 30' E 400 ft to beginning.
